On May 1, 2026, I was assigned to the PS housing unit. At approximately 1237 hours, I heard an incarcerated individual, later identified as II Luke Wenke (ID # [REDACTED]), yelling for help and screaming, "Why me?" from inside his assigned cell. At that time, I observed incarcerated individual [REDACTED] exit [REDACTED] close the door behind him, and return to his assigned cell, where he sat on his bunk. As I approached [REDACTED] I observed that II Wenke had visible [REDACTED] injuries.

I ordered the unit to lock in and had II Wenke escorted to Booking Medical, where he was evaluated by RN [REDACTED] and subsequently transported via jail car by security staff to Strong Memorial Hospital for further evaluation of [REDACTED]. II [REDACTED] was handcuffed and escorted to Reception Medical, where he was evaluated by RN [REDACTED] and cleared for relocation to the second floor. Corporal Minnis was notified.

On 5/1/26 I conducted an investigation into Incident 2600855, a physical altercation that occurred in Plaza South. The following II's were questioned and their responses are as follows:

II Luke Wenke [REDACTED] – I have no idea why he ([REDACTED]) hit me. Our doors were opened at 12:30 to come out, and he came in and beat me up. I look out for that guy too. I gave him stamps today. I don't know why he would do that to me.

[REDACTED] – He (Wenke) knows exactly what he said. This was an isolated incident. I don't do this, unless provoked. I have no problem with the officers here, no problem with the inmates here. This was isolated, and he knows exactly what he said. But I will not repeat it.

[REDACTED] – I'm not sure why they fought that dude ([REDACTED]) is typically so quiet. He doesn't say much of anything.

No other II's commented on the cause of the fight.

After review of the enhanced video recorder ([REDACTED]) it can be concluded that [REDACTED] entered the cell assigned to Wenke because [REDACTED] perceived Wenke made disrespectful comments directed toward him earlier in the day. Proper non-contacts entered.
